The Guardian:

1. Affirms that the Minor Participant is physically and psychologically fit to participate to the Ferney Trail 2018. He confirms that the Minor Participant is in good health and is not suffering from any disability and/or any disability that might endanger the life of the Minor Participant or the participant or that of any other third party throughout the race.
2. Acknowledges his full awareness of the wild and natural character of the slopes and of the difficulty of the race, and declares that the Minor Participant is physically fit to undertake such a race in such given natural conditions
3. Understands and agrees that the race is performed at the Minor Participant's own risk. The Guardian agrees to assume full responsibility for the Minor Participant throughout the duration of the race.
4. Acknowledges that the Minor Participant has been specifically informed of the safety standards to abide by and of the importance to strictly respect the organisers' instructions. 5. Admits that, in case of non-compliance by the Minor Participant to the directions or instructions of the organisers and/or officers of the Company throughout the race, the Company reserves the right at any time to stop the Minor Participant from continuing such race. The Guardian expressly acknowledges and hereby agrees that, in such a case, no refund will be made by the Company to him on behalf of such Minor Participant.
  
6. Commits to assume entire responsibility for the personal effects of the Minor Participant throughout the hiking process.
  
7. Will make sure that, if the Minor Participant is aged less than ten (10) years, he/she will be accompanied throughout the journey (from start line to finish).
  
8. Agrees that the Company, its officers and/or directors will, in no case whatsoever, be held responsible for any material, corporal and/or moral loss or damage whatsoever, that may be suffered by the Minor Participant further to his/her participation to the Ferney Trail 2018, except from any such material, corporal and/or moral loss or damage whatsoever, arising due to gross negligence by the Company and/or its employees.
  
9. Expressly waives any claim of whatever nature it may be, against the Company, its officers and/or directors because of the Minor Participant's participation to the Ferney Trail 2018, except for those arising from the gross negligence by anyone of the former.
  
10. Agrees to guarantee the Company, its officers and/or directors against any request or claim which may have been made or lodged against one of them by a participant, parent or guardian of a minor participant or of a third party, to repair any damage caused whether directly or indirectly by the Minor Participant during the race, or more generally, during the "Ferney Trail 2018" event.

The terms of the presents shall be construed and enforced in accordance to the law of Mauritius. Disputes or litigations that may arise from the application or interpretation of same will, in the absence of a mutual agreement, be subject to the jurisdiction of the Courts of Mauritius, whose jurisdiction is hereby expressly recognised.
